Step 1:

atmospheric radiation

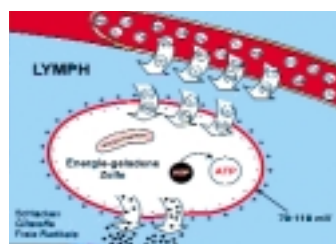

Step 2:

Transportation of Ions

Step 3:

The resonance phenomenon
